RESPONSIBLE PROCUREMENT

Objectives

At dstelecom we acknowledge the importance of adopting ethical and sustainable practices in all our acquisitions of goods and services The Responsible Procurement Policy reflects our commitment in the promotion of environmental sustainability, business ethics and respect for human rights, contributing to sustainable economic development and the creation of value throughout the supply chain.

This policy aims to establish precise guidelines to ensure that all transactions undertaken by dstelecom are conducted in a socially conscious manner, with ethical and sustainability considerations at the heart of the decision-making process.

Scope of Application

This policy is applicable to all employees, suppliers, partners, and any third parties involved in the procurement of goods and services by dstelecom.



PRINCIPLES OF RESPONSIBLE PROCUREMENT

Environmental Sustainability

dstelecom prioritizes the acquisition of products and services that minimize their environmental impact. This commitment reflects the preference for products that are recyclable, biodegradable, energy efficient and have a reduced carbon footprint, whenever viable and available on the market. Environmental sustainability practices will be taken into consideration in all purchasing processes, constantly seeking to contribute to a more sustainable environment and promoting awareness of the importance of environmental responsibility in commercial transactions.

Business Ethics

dstelecom is fully committed to ensuring that its purchases of products and services come from suppliers who operate in accordance with the highest ethical standards, favoring partners who share the same values in relation to corporate social responsibility. This means that we seek to establish partnerships with organizations that are committed to transparent business practices, respect human rights, combat labor exploitation and promote equal opportunity and diversity in their work environments.

Accountability will be a central pillar of dstelecom's partnerships, ensuring that high ethical and social responsibility standards are met throughout the supply chain. For this reason, dstelecom will demand transparency from its suppliers, requesting detailed information about the origin of their products, manufacturing processes and social and environmental practices.

Respect for Human Rights

dstelecom adopts an uncompromising stance regarding the acquisition of products and services from suppliers that are involved in practices that violate human rights. These practices include, but are not limited to, forced labor, child labor and discrimination.


We conduct regular checks to ensure that our suppliers comply with labor and human rights protection laws and regulations.


Integrity and respect for the fundamental rights of all individuals are central pillars of dstelecom's responsible procurement policy.
